

Springfield Figure Skating Club Membership Application



WHY JOIN THE SPRINGFIELD FIGURE SKATING CLUB? When you become a member of the Springfield Figure Skating Club (SFSC), you will be able to skate on ice at specific times available at a special rate to club members to practice your skating skills. Club Ice session fees are 45 minutes in length. Your SFSC membership also allows you to participate in exhibitions, tests, competitions, seminars, parties, outings and our annual "Spotlight On Ice" show. While many of our members choose to compete, competition is not a requirement. Members receive a 20% discount on Learn to Skate classes and birthday parties held at the Nelson Center. By joining the Springfield Figure Skating Club you are also becoming a member of US Figure Skating. Your membership includes a subscription to US Figure Skating's, "SKATING" magazine and SFSC newsletters.

WHAT ARE YOUR OBLIGATIONS? Membership runs July 1 thru June 30. In addition to the below membership fee; SFSC requires that each family volunteer 20 hours of service to the SFSC (10 during Spotlight on Ice). Each family also agrees to fulfill Spotlight on Ice obligations of selling a minimum of \$300 in advertising and \$50 in show tickets. Supporting family memberships are not required to partake in volunteer hours or financial obligations.

SFSC Membership Fee	\$ 50
US Figure Skating Dues	\$ 40 first family member \$ 15 each additional family member

Please note: because we run concurrent with US Figure Skating we do not pro-rate membership fees.

TOTAL MEMBERSHIP FEES

- 1 member — \$90 (*all skaters under 18 must join with parent or guardian*)
- 2 members — \$105
- 3 members — \$120
- 4 members — \$135 (*add \$15 for each additional member*)

The above fees are for current skating members / families of the SFSC. SFSC Supporting memberships are also available for individuals wishing to belong to the SFSC/US Figure Skating but who are not currently active skaters.

Note: Individuals joining as a family membership must reside in the same household.
